The oldest historical society in the United States is what we now call the Massachusetts Historical Society, which was founded in 1791 by Jeremy Belknap. The PHA was founded in 1987. Our society is well attended, strong, and vibrant. However, there are challenges on the horizon for which we must prepare. There is much evidence indicating that those who support local history endeavors are aging and the prospects of engaging young adults are challenging.

Written on November 14, 2016, an unknown blogger for AASLH (American Association for State and Local History) makes an interesting observation in a blog, *Historical Societies and the March of Time*. The unnamed author states:

The typical local historical society board member has strong ties to his or her community. He can say, "I was born on Main Street, right between the Smith house and the Washington house. My dad ran the local gas station, right over there, and my mom taught at the elementary school for 36 years." How many of us can say that anymore? We have become transient as a society and no longer can claim that the old adage "you marry someone born within 25 miles of where you were born" is absolutely true. We're not local in nature anymore. There will be fewer and fewer people with long, deep knowledge of local landscapes, people who are really dedicated to the preservation of their hometown history.

That is precisely the same challenge facing the PHA. Over the coming year we must understand, plan, and implement the plan to reach young adults while attracting others. Your ideas will be important. Please note the following:

Clydetta Fulmer, Sculptress

Pintlala Historical Association is truly proud of our friend, member and local artist, Clydetta Fulmer. Her primary artistic medium is sculpture. On October 25, 2019 one of her 2019 works was unveiled on Montgomery's South Perry Street opposite City Hall. This impressive bronze representation of American Revolutionary War hero, Major General Richard Montgomery, honors the 1738-1775 soldier for whom the City of Montgomery was named. The completed bronze statue, cast by the Lost Wax Method at the Wegner Metal Arts Foundry of Fredericksburg, Virginia, stands over six feet tall and weighs 600 pounds.

Additionally, her most recent sculpture of Civil Rights icon, Rosa Parks, was unveiled in Montgomery near Court Square Fountain on Sunday, December 1, 2019 as a part of the Rosa Parks Day celebration.

Alan M. Davis and the Alabama Mayflower Society

Alan M. Davis, PHA member, is currently completing his second year of a three-year term as Governor (president) of the Alabama Mayflower Society. He also represents the State Society on the General Society's Board of Assistants as Deputy Governor General. The Alabama Mayflower Society was chartered in 1952. The AMS is a Member Society of the General Society of Mayflower Descendants, which is headquartered in Plymouth, Massachusetts and was founded in 1897.

The Alabama Mayflower Society is organized into four geographical chapters or Colonies. These are: Cahaba River, Capital, Gulf Coast and Tennessee Valley Colonies. The Alabama Mayflower Society claims 290 members.

Membership is based on documented descent from one (or more) of the 51 original Pilgrims who sailed to America aboard the ship, Mayflower, in 1620. Applications for membership must be verified by the General Society of Mayflower Descendants in Plymouth. PHA members who are known to be in the Mayflower Society are Rickey McLaney and Norma Stubbs Pogue. Deceased PHA members Ronald Sellers, Vera Kraus, Virginia and Catherine Sellers were AMS members.

The mission of the Alabama Mayflower Society is to promote Mayflower history and ideals.
